GENERAL TERMS OF USE

IMPORTANT! READ THIS ENTIRE AGREEMENT CAREFULLY

EASIER WITH MOBIL REBATE PROGRAM

Effective January 1, 2025, ExxonMobil and Imperial are proud to offer the Easier with Mobil Rebate Program (“**Program**”).

Terms and Conditions

This loyalty rebate program agreement (“**Agreement**”) is between:

you, a construction-related customer of an authorized Mobil lubricant distributor (“**Customer**”);
and

ExxonMobil Product Solutions Company, 22777 Springwoods Village Parkway, Spring TX, 77389 (“**ExxonMobil**”), with respect to residents of the United States of America; or

Imperial Oil, 505 Quarry Park Blvd, Calgary AB, T2C 5N1 (“**Imperial**”), with respect to residents of Canada,

(ExxonMobil and Imperial each a “**Sponsor**” in its respective jurisdiction, and collectively, “**Sponsors**”).

Between January 1, 2025, and December 31, 2026, inclusive (the “**Promotion Period**”), purchase enough volume of Mobil branded lubricants (an “**Eligible Products**”) from an authorized ExxonMobil or Imperial distributor and become eligible for the rebates as described below.

This Program is limited to purchases of Eligible Products.

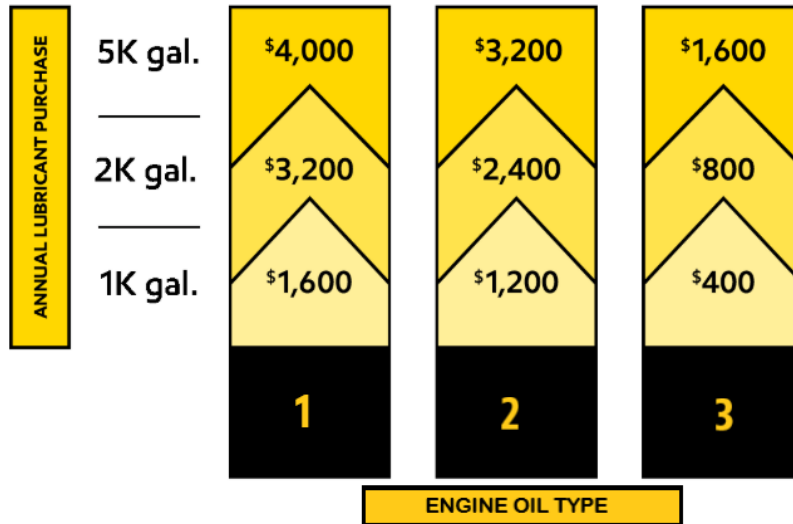
To be eligible to receive a rebate pursuant to this Program:

- Customer must have purchased less than 250 Gal (US) / 1,000L (Canada) of Eligible Products in the last twelve (12) months and have not enrolled in this Rebate Program in the past.
- Purchase a sufficient volume of Eligible Products during the Promotion Period from a Sponsor's authorized distributor.
- Enrollment in the Promotion must be submitted before December 31st, 2025 and Online claim form completed before December 31, 2026.

Rebate Structure:

- Rebates to eligible Customers vary according to territory, Eligible product sales, and volume according to this Agreement. All volumes of Eligible products are aggregate under one rebate category (1, 2 or 3). The rebate category is based on the highest volume of Mobil Delvac Engine oil purchased during the 12-month period per the table below.
- **Sign-on Rebate of \$200** will be disbursed only when the minimum additional volume of 250 Gallons (US) / 750 liters (Canada) of **Eligible Products** is purchased within 90 days of the first date of purchases or initial claim submission date (which ever come later) as shown by the proof of delivery/deliveries and eligibility is verified, in Sponsor’s sole discretion.
- The quantity of “Annual Lubricant Purchase” is determined based on only the first twelve (12) months following a Customer’s first purchase date or claim submission date (which ever come later). All program registrations and claim submissions must be completed by December 31, 2026.

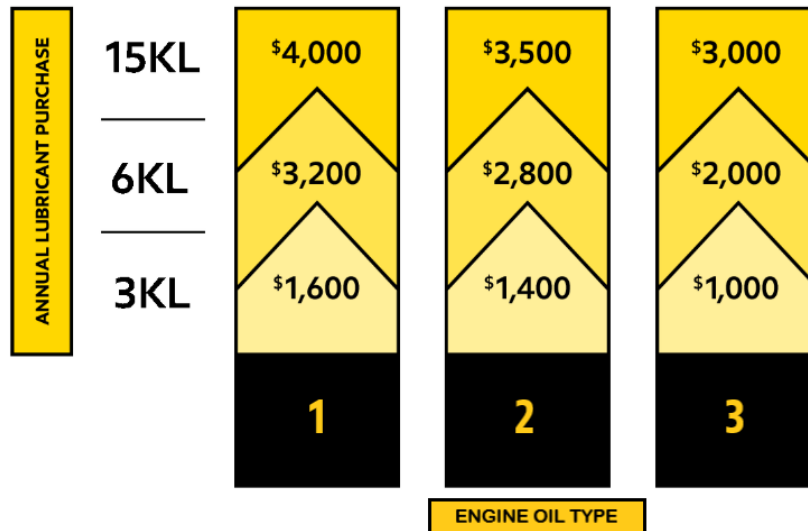

Receiving A Rebate:

- Customer shall visit <https://promotions.mobil.com/for-business/construction/easierwithmobil/> and create an account by completing the registration form to be eligible to participate. Eligible Customers will be dispersed appropriate Rebates according to the tables above, in Sponsor's sole discretion according to this Agreement. Rebates will be dispersed in the customer name only.
- NOTE: Actual rebates paid will be determined by the actual final volume of Eligible products and by the rebate category, based on the highest volume of engine oil purchased.

Offer conditions: By participating in the Program, Customer agrees to be bound by the terms and conditions in this Agreement. Offer is open only to legal residents who have reached the legal age of majority in their state/province/territory of residence at the time of submission. No PO boxes allowed.

Void where prohibited, restricted or taxed. Redemption forms or submissions using the same mailing address and/or the same IP address will be deemed to be from the same person. Each Rebate claim must contain a fully completed form and original receipt(s) dated during the Promotion Period. Allow approximately six to twelve (6-12) weeks for Rebate shipment or email delivery from domain “@apfmailer.com” to the address or email address provided with the registration from, following receipt and verification of all required documentation.

Sponsors are not responsible for replacing the Rebates, if lost, stolen, destroyed, damaged, or used without a participant’s knowledge or consent.

Offer cannot be combined with any other offer. Incomplete, damaged, photocopied, mechanically reproduced, altered and/or forged receipts or redemption forms of any kind, or receipts or redemption forms not obtained through authorized channels, will not be accepted. Invalid or duplicate requests will not be honored or returned. Sponsors, their parents, affiliates, subsidiaries, suppliers, advertising/promotion agencies, and all other individuals and entities involved in the development, production, administration or fulfillment of the Program, and each of their respective officers, directors, employees, agents, representatives, successors and assigns (collectively, “**Released Parties**”) are not responsible for late, lost, stolen, illegible, damaged, incomplete, misaddressed, misdirected, delayed, inaccurate or postage-due mail, or for any errors of any kind relating to this Program. All requests become the property of Sponsors and are nonreturnable. Sponsors have no obligation to acknowledge, redeem or return redemption requests not in compliance with these terms. This Program may not be published in any magazine or elsewhere without Sponsors’ written permission. Trading, buying, selling or manufacturing of receipts or redemption forms is considered to be in violation of the terms of this Program. By participating in the Program, an eligible Customer hereby: (i) confirms compliance with these terms; and (ii) releases Sponsors and all of the other Released Parties from any and all liability in connection with the Program, their participation therein and/or the awarding and use/misuse of rebates.

Sponsor reserves the right, in its sole discretion, to require proof (in a form and substance acceptable to Sponsor): (i) for the purposes of verifying the eligibility and/or legitimacy of any information for the purposes of this Program; and/or (ii) for any other reason or reasons that Sponsor deems necessary, in its sole discretion, for the purposes of administering this Program in accordance with Sponsor’s interpretation of the letter and spirit of these terms. Failure to provide any such proof to the reasonable satisfaction of Sponsor within the timeline specified by Sponsor may result in disqualification. SPONSOR HAS THE RIGHT, IN ITS SOLE DISCRETION, TO TAKE WHATEVER MEASURES OR ACTIONS IT DEEMS NECESSARY TO HELP ENSURE THAT THE PROGRAM IS ADMINISTERED IN ACCORDANCE WITH SPONSOR’S INTERPRETATION OF THE LETTER AND SPIRIT OF THESE TERMS.

The Released Parties will not be liable for: (i) any failure of any website or any platform during the Program; (ii) any technical malfunction or other problems of any nature whatsoever; (iii) the failure of any information to be received, captured or recorded for any reason whatsoever; (iv) any injury or damage to any Customer’s or any other person’s computer or other device related to or resulting from participating in the Program; and/or (v) any combination of the above. For Québec residents, this release does not apply if the failure, injury or damage is the result of Imperial Oil’s own act.

CUSTOMER AGREES THAT 1.) ANY AND ALL DISPUTES, CLAIMS, AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE PROGRAM, OR ANY REBATES AWARDED, SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; 2.) ANY AND ALL CLAIMS, JUDGMENTS, AND AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, INCLUDING COSTS ASSOCIATED WITH ENTERING THE PROGRAM BUT IN NO EVENT ATTORNEYS' FEES; AND 3.) UNDER NO CIRCUMSTANCES WILL ANY CUSTOMER BE PERMITTED TO OBTAIN ANY REBATE FOR, AND CUSTOMER HEREBY WAIVES ALL RIGHTS TO CLAIM, PUNITIVE, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES AND ANY AND ALL RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED AND ANY OTHER DAMAGES, OTHER THAN FOR ACTUAL OUT-OF-POCKET EXPENSES, AND ANY AND ALL RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED.

Sponsor reserves the right, in its sole discretion, to cancel, withdraw, amend or suspend this Program (or to amend these terms) in any way, and especially in the event of any cause beyond the reasonable control of Sponsor that interferes with the proper conduct of this Program as contemplated by these terms, including, but not limited to, any error, problem, tampering, unauthorized intervention, fraud or failure of any kind whatsoever. Any attempt to undermine the legitimate operation of this Program in any way (as determined by Sponsor in its sole discretion) may be a violation of criminal and civil laws and should such an attempt be made, Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law.

Each Customer expressly consents to Sponsor, its agents and/or representatives, storing, sharing and using any personal information submitted for the purpose of administering the Program and in accordance with Sponsor's privacy policy (in the case of ExxonMobil <https://corporate.exxonmobil.com/global-legal-pages/privacy-policy> and in the case of Imperial Oil: <https://www.imperialoil.ca/en-CA/Legal-pages/Privacy-statement>). This section does not limit any other consent(s) that an individual may provide Sponsor or others in relation to the collection, use and/or disclosure of their personal information.

The invalidity or unenforceability of any provision of these terms shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these terms shall otherwise remain in effect and shall be construed in accordance with the terms as if the invalid or illegal provision were not contained herein.

To the fullest extent permitted by applicable law, all issues and questions concerning the construction, validity, interpretation and enforceability of these terms or the rights and obligations of participants, Sponsor or any of the other the Released Parties in connection with the Program will be governed by and construed in accordance with the domestic laws of the state of Texas, with respect to ExxonMobil, and the Province of Alberta and the federal laws of Canada, with respect to Imperial Oil, applicable therein, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws; and (b) the participant consents to the exclusive jurisdiction and venue of the courts located in the state of Texas, with respect to ExxonMobil, and Alberta, with respect to Imperial Oil, in any action to enforce (or otherwise relating to) these terms or relating to this Program.

The obligations and liabilities of Imperial and ExxonMobil under this Agreement shall be several, not joint. ExxonMobil alone shall be solely responsible in respect of sponsorship in the United States, and Imperial alone shall be solely responsible in respect of sponsorship in Canada.
